Historic Ruling Denies Immunity for Donald Trump in Capitol Insurrection Lawsuit

WASHINGTON, D.C. - A this country - not even a former groundbreaking decision this week president. This is an essential step allows the lawsuit accusing former President Donald Trump of inciting the January 6th Capitol insurrection to move forward, denying immunity for conduct committed by a sitting president for the first time in history. absolute immunity against the allegations, brought by 10 members of Congress, which alleged that he, along with the Proud Boys and Oath Keepers, conspired to incite a violent riot at the U.S. Capitol on January 6th, 2021. In his decision, Judge Amit P. Mehta of the United States District Court for the District of Columbia wrote: "To deny a President immunity from civil damages is no small step. The court well understands the gravity of its decision. But the alleged facts of this case are without precedent, and the court believes that its decision is consistent with the purposes behind such immunity." Judge Mehta also denied motions to dismiss from the Oath Keepers and Enrique Tarrio of the Proud Boys.

cision today and look forward to continuing to pursue justice. An attack on democracy must be met with the full force of our criminal justice system," said Janette Mc-Carthy Wallace, NAACP General Counsel and co-lead counsel.

'Today is a major victory for the rule of law, and demonstrates just how important the courts are for ensuring accountability. This exhibits the finest tradition of our legal system - evaluating cases on their merits, not politics. We will continue to pursue justice through the courts and ensure accountability for this attack on our democracy," said Joseph Sellers, partner at Cohen Milstein Sellers & Toll and co-lead counsel.
